Exhibit Hall Set-Up: The exhibit hall will be available for set up on Saturday, January 15<sup>th</sup>. as follows:

- Vehicle Move In: 8:00 AM 10:30 AM. All vehicles will move in during this time only on a schedule to be
  determined by the associations. No exceptions will be made. Fern must spot all vehicles in and out of the hall.
  Once all vehicles are in place Fern will set up the rest of the booth spaces, place booth signage, and deliver any
  freight shipped by exhibitors.
- Exhibit Set Up by All Exhibitors: 11:00 p.m.-4:00 p.m. All exhibits must be set up by 4:00 p.m. so the decorator can finish laying the aisle carpet and clean the hall.

<u>Insurance:</u> Exhibitors in the Show must carry: Statutory limits for workers' compensation coverage; and Commercial general liability including products and completed operations, independent contractors' personal injury and blanket contractual liability insurance limits of at least \$1,000,000 per occurrence, \$2,000,000 aggregate. These coverages must be evidenced by a Certificate of Insurance with a 30-day notice of cancellation provision to the holder. The certificate must name ADED, Inc as additional insured and be uploaded to the exhibitor portal at least 30 days before the exhibit start date. # **Auto Mobility Expo Exhibitor Information January 15-17, 2022 | Columbus, OH**

### Requirements for Vehicles in the Expo

All display vehicles or machinery must adhere to the following:

- Equipment is to have no more than (1) one gallon of fuel.
- Gas cap must be lockable or taped to prevent leakage of fumes from tank.
- Both battery cables must be disconnected and secured away from the battery.
- Vehicles will be inspected prior to placement with a set of keys turned over to event security.
- The transfer of fuel is not allowed on GCCC premises.
- Fern will charge a \$50 spotting fee per vehicle (fee includes in and out).

#### Other:

- Each vehicle must be properly labeled with required compliance labels.
- Untested or prototype products/vehicles must be labeled as such.

**Exhibit Height:** Booth height may not exceed 8' and cannot obstruct the view of or interfere with traffic to other exhibits unless you submit a floor plan of your booth and receive prior approval from show management.

**Exhibit Tear Down:** Tear down will begin immediately after closing on Monday. No early teardown is permitted. A company representative must be present in your booth during all hours of exhibit operation from Saturday through Monday. Failure to comply with this will result in your company not being permitted to exhibit at future conferences.

<u>Audio Visual Displays in the Exhibit Hall</u>: Audio visual displays must be approved by Show Management prior to the conference and may not interfere with other booths or extend into the aisles and height should not interfere with traffic to other exhibitors. Exhibitors with audible electric devices, sound video or motion pictures, or other exhibits or devices, which might prove objectionable to other exhibitors, may be asked to accept booth assignments that diminish reasonable objections.
