50% of the total fee to guarantee Booth Space is due with the signed contract. Balance is due on or prior to February 16, 2018. If payment is not received by this date, Show Management reserves the right to charge the remaining balance on the original credit card provided by the Exhibitor to confirm the Booth Space (deposit). Show Management may, at its discretion, release the Booth Space if payments are not made in accordance with the payment schedule. Cancellation of Booth Space due to missed or late payment does not relieve Exhibitor of its obligations under this Agreement. Please review all terms and conditions noted herein with regards to Payment Terms, Penalties, and Late Payments.

CANCELLATION POLICY:

Once this Exhibitor Agreement is signed by the Exhibitor and confirmed by Show Management, you are contracted to the Booth Space. Requests to cancel Booth Space (either entirely or downsizing) must be submitted from the Exhibitor in writing. The parties acknowledge that the actual damages likely to result from the Exhibitor cancellation are difficult to estimate on the date of this contract and would be difficult for Show Management to prove. Therefore, the parties intend that Exhibitor will remain liable for the original Booth Space fee amount as liquidated and agreed upon damages and not as a penalty.

REPRESENTATIONS:

Exhibitor represents and warrants that (a) if an entity, Exhibitor is organized, validly existing and in good standing in the state of its formation; (b) Exhibitor has the authority, legal right and power to execute, deliver and perform all of its duties and obligations contained in this Exhibitor Agreement; (c) the performance by Exhibitor of its duties and obligations hereunder, have been duly authorized by all requisite action (corporate or otherwise) on the part of Exhibitor; and (d) this Exhibitor Agreement constitutes a binding and valid obligation of Exhibitor, enforceable against Exhibitor in accordance with its provisions.
